5. The legal basis for using personal data, as provided by you on the membership form is:

The legitimate interest for all information except for:

- i. Your photograph in printed form, video, or on our website.
- ii. Your name appearing in choir concert programmes, video or on our website.

In these cases, assumed consent is the legal basis governing the retention and use of these items of personal data, which can be freely given or withheld. Please inform the Secretary if you wish to withdraw consent for such use of your image or name.

Your emergency contact information, which allows us to look after your wellbeing in the event of an emergency, a health and safety issue, or because you have asked us to make contact, will only be used for the purpose of which it was obtained.

7. The recipients of personal data:

Choir Committee members receive:

Full name, phone number, email address and emergency contact details.

8. The retention periods for personal data:

For Choir members, and past members, a maximum of 5 years from the date of the last submission of their personal data.

You have the right to:

- View your personal data that we hold.
- ii. Know how your personal data is held and for what purpose.

The Choir Committee will keep your data securely in a secure folder in cloud storage, with Dropbox Pro and Mailchimp. The Secretary will inform you promptly should any data breach occur.
